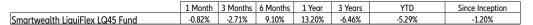

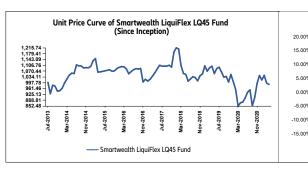

Manager Commentary

LQ45 declined -0.27% in April on a total return basis. Foreign investors were net sellers for two consecutive months. Healthcare and utilities saw selling pressure while the energy and consumer discretionary sectors outperformed. Indonesia recorded another trade surplus with both exports and imports being much stronger than expected. CPO drove exports higher on rising volume and prices while oil price contributed to the import's growth. Bank Indonesia (BI) maintained the benchmark rate at 3.5%. BI reiterated that it will optimize quantitative measures and accelerate monetary transmission to support recovery.

Our market trend and momentum assessment of Indonesian stock market remained positive during April, though momentum has weakened slightly. Local economic environment continued to recover. Considering the favourable market outlook, we have maintained a full-investment positioning throughout the month.

The fund underperformed the benchmark in the month of April. The lack of exposure to one of the telecom tower companies impacted performance negatively. The name rose on speculations that it might an acquisition target as the country opens up the sector to foreign investments.
