



Manager Commentary

LQ45 rose 4.62% on total return basis in August. Foreign investors turned net buyers for the first time after 3 months of outflows. The foreigners favoured the large caps given the solid 2Q numbers and liquidity. Industrial and utilities counters saw healthy buying during the month while the information technology sector lagged. The country's GDP grew 5.44% year-on-year (YoY) in 2Q, driven by strong private consumption and net exports. Services related spending (transportation, hotels, restaurants etc.) accelerated +5.5% YoY due to Lebaran holiday while net exports was driven high commodities prices. Investments, on the other hand, decelerated to +3.07% YoY in 2Q. In the 2023 droft budget, the government set its 2023 GDP growth and inflation target at +5.3% YoY and 3.3% respectively under the assumptions of Rp14,750/USD and USD90/bbl oil price. The mail focus is to nurse the deficit back to below 3% as the economy normalizes. Based on our market trend and fundamental assessment, the overall market outlook of Indonesian equities has improved from negative to slightly positive over the month ofAugust. Effective 15 August 2022, the allowable range of equity allocation for the fund has been changed from 0-100% to 0-79%. As a result of our market outlook as well as the guideline change, we have maintained around 96% equity exposure in the portfolio during the first half of the month and moved to 79% equity exposure since 15 August 2022. Such full-investment positioning has been maintained towards the end of the month. The equity component of the fund outperformed the LQ45 Index in the month of August. The positive stock selections in the financial and consumer staple sectors were the main drivers of the outperformance.
