



## **Manager Commentary**

LQ45 fell -0.35% (price-change return) in August. Foreign investors turned massive net sellers during the period, offloading USD1.3bn worth of equities. Technology names faced the brunt of the selling once again as competition in the sector remained fierce. Material and financial counters, on the other hand, saw renewed buying interest as commodity prices stabilised. Coal counters also performed well as coal prices staged a rebound in recent months. On the macro side, July inflation grew +3.08% year-on-year (YoY), slightly better than expectation. Bank Indonesia (BI) held the policy rate at 5.75% while being confident of containing inflation within its 2-4% target for the year. The Central Bank also reiterated its GDP target at 4.5%-5.3% for the same period. Elsewhere, bank credit growth remained buoyant at 8.5% YOY in July. Based on our market trend and fundamental assessment, the overall market outlook of Indonesian equities deteriorated from positive to mildly based on our many ba the potential listing of its geothermal business.
