



Manager Commentary

LQ45 posted a total return of 5.58% in June despite foreign investors selling USD317 million of equities. Utilities and Industrials performed strongly while materials and consumer lagged behind. The month started positively as sentiments improved on the back of sizeable government stimulus packages and of the gradual reopening of the economy. Domestic activities accelerated as Indonesia relaxed the social distancing requirements. Bank Indonesia (BI) lowered its benchmark rate by 25bps to 4.25%. The rate cut came on the back of benign inflation and stable exchange rate. BI also came out with a lower growth target range for 2020 at +0.9% to +1.9% vs +2.3% earlier. They are expecting a much weaker 2Q and a recovery in 2H.

Whilst our market trend and momentum of Indonesian stock market remains in negative territory, it has become modestly less negative with the market showing signs of stabilization and improvement. LQ45 Index continued to experience volatility. The Index rollied by over 9% during the first 8 days of June, but gave back some of the gains over the rest of the month. Overall, given the modestly improved market sentiment, we have gradually increased equity exposure to around 78% by the end of June, from 55% as of May.

The fund outperformed the benchmark in the month of June. Stock selections in the consumer staples and industrials contributed positively to the performance. Conversely, the underweight position in the energy sector affected the performance negatively.
