

S&P 500 up in the month of December (+4.36%). Economic data also shows a better than consensus U.S. Jobless Claims data. On December FOMC meeting, Fed Chairman, Jerome Powell suggested that the Fed will do a tapering at a faster rate, as a contingency plan from a raising rate of inflation in the US. The fed has started to heavily reduced monthly bond purchase, and eventually can rise the interest rates in 2022. JCl closed relatively higher on the month of December (+0.73%), marking 22 years straight of positive return in the month of December. Indonesia 10-yr Government bonds yield's rise by 0.116% in December 2021. Bank Indonesia projected the inflation on FY2021 at 1.9% YOY and 0.6% MOM in December 2021. Hence, the central bank stated that they can start raising the interest rate again by 3Q2022. We maintain Overweight position in infra, transportation and property sectors.
