



JCI in December 2019 closed at 6299.539 books 4.97% return. Positive return in JCI contributed from Agri, Mining and Financial sector. On the other hand, sectors that underperforming index in Dec are trade & services, infrastructure and consumer sector. Lower trade tension between US and china and trade deal phase on creating risk on environment. Meanwhile, IDR also strengthening and closed at 13,863 level from 14,105 at the end of November. We maintain our overweight position in agriculture, financial and misc sectors.
