



Manager Commentary

Global Equities performance are very volatile recently, due to the crisis in Eastern Europe between Russia and Ukraine. This was followed by further escalation from both sides. On top of that, US CPI number was 7.5% yoy, above market expectation, reaching four-decade high. Meanwhile, commodity prices went up, due to rising geopolitical risk may impact supply. US Indices closed lower on February, S&P 500 Index (-2.45%), Dow Jones Industrial Index (-3.42%), Nasdaq Composite Index (-1.89%). To the contrary, JCI Index closed higher (+3.88%) in February, supported by foreign net buys (USD 1.2 Billion) in the month of February. Indonesian 10-yr Govt bond yield is relatively flat (+0.06%) in February, despite net foreign buy of Indonesian Government bond (USD 827 Million).
