



Manager Commentary

LQ45 rose strongly in October, returning +6.56% on total return basis. The market saw the strongest monthly foreign inflow year-to-date. The Utilities and financial sectors led the market while energy names lagged. Decent quarterly results boosted sentiments of utilities counters. Coal miners fell as investors took profit on the back of weaker price outlook due to slower demand. Bank Indonesia (BI) maintained the benchmark rate at 3.5% for the eighth month in a row. The Central Bank continues to focus on stabilizing exchange rate and inflation. It will also maintain adequate liquidity in the system while extending several policies such as lower down payments in housing automotive loans till 2022. The Indonesian stock market was boosted by an improvement in the domestic COVID situation as well as the easing policy by the central bank. Our market trend and momentum assessment of the market strengthened to positive since the beginning of the month. We have moved to a full investment positioning since mid-October and maintained such position till the end of the month.

The fund outperformed the benchmark for the month of October. Positive stock selections in the consumer sectors contributed to the bulk of the outperformance. The underweight positions in the utilities names, however, offset some of it.
