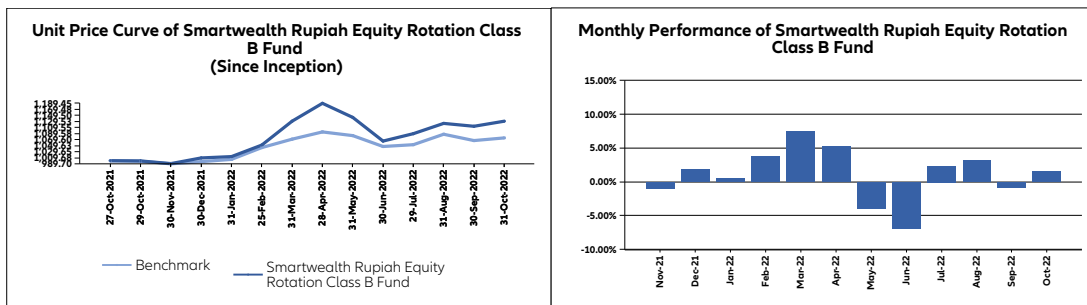

**Manager Commentary**

Global Equities closed higher in the month of October, major global indices such as S&P 500, Dow Jones Industrial Index, Nasdaq Composite Index and MSCI World Index closed +7.99%, +13.95%, +3.90%, +7.11% respectively. US GDP on the 3rd Quarter of 2022 has reported an increase of +2.6% YoY (vs +2.4% YoY Consensus). In addition, US Jobless Claims is lower than expected (217k actual vs 220k consensus). However, investors are still mulling on the possibility of higher-than-expected inflation, that could lead to more aggressive rate hike by the Fed. Jakarta Composite Index has also recorded a positive return of +0.83% in the month of October. Bank Indonesia has increased the 7 Days Reserve Repo Rate to 4.75% from 4.25%, an increase of 50 bps amid Rupiah depreciation. Indonesia Headline Inflation rose +5.71% YoY (vs 5.99% consensus), slower compared to September 2022 data of +5.95% YoY, on the back of lower food prices. Indonesia 10-year government bond yield closed at 7.54%, an increase of 0.16% compared to last month.
