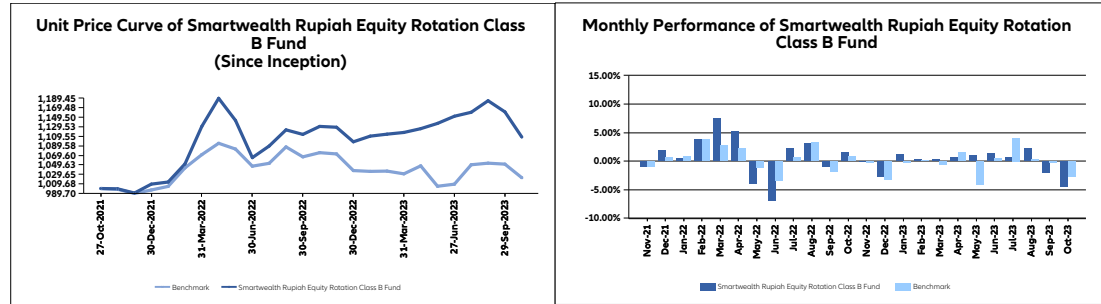

### Manager Commentary

Global equities mostly closed lower in the month of October 2023. Major global indices such as S&P 500 Index, Dow Jones Industrial Index, Nasdaq Composite Index and MSCI ACWI Index closed -2.20%, -1.36%, -2.78%, and -3.07% respectively. 10 Years US Treasury Notes yield closes at 4.88% in the end of October 2023, up around 31-bps from 4.57% in September 2023. Federal Fund Target Rate are kept unchanged at 5.25% - 5.50% on their most recent FOMC meeting. US GDP grew at 4.9% QoQ on Q3 2023, above the market expectation at 4.3% QoQ. On top of that, US core PCE rose 0.3% MoM/3.7% YoY, in line with market expectations. In addition, the Jakarta Composite Index recorded also recorded a negative return of -2.70% in the month of October 2023. Bank Indonesia surprisingly hiked the 7 Days Reverse Repo Rate to 6% in the month of October 2023. Indonesia 10-year government bond yield closed at 7.07% at the end of October 2023, an increase of 16-bps compared to last month (6.91% on September 2023).
