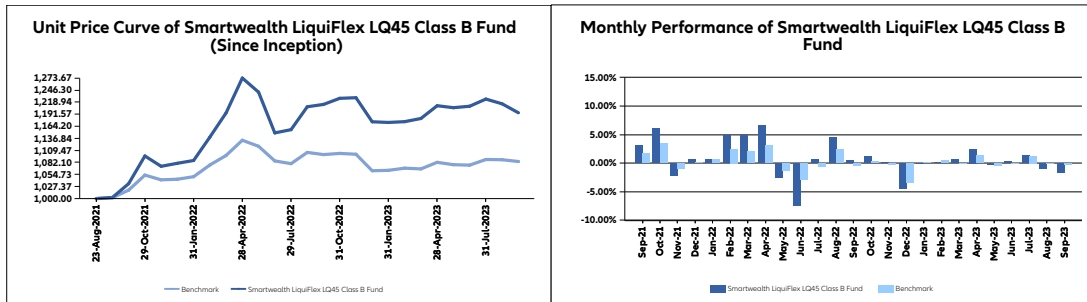

Manager Commentary

LQ45 Index fell -0.99% (price-change return) in September. Foreign investors were net sellers for the second consecutive month, selling USD262m worth of equities. Energy and material names were the winners while consumer discretionary lagged. Rupiah was also sold off during the period, depreciating -1.51%. On the macro front, inflation edged up to 3.3% year-on-year (YoY) in August from 3.1% in July of which food price increase was the primary driver. Bank Indonesia (BI) held benchmark rate steady at 5.75%. The Central Bank expressed confidence in growth prospects and exchange rate stability. It will, however, remain vigilant on containing inflation. Elsewhere, consumer confidence in August remained buoyant with the job market being healthy. Bank credit growth held up 9.1% YoY in the same month as mortgage credit expanded 10% YoY in June-July. This strengthened the prospects of a recovering residential market. All in all, the economy appeared to be on firm footing and is growing well. Based on our market trend and fundamental assessment, the overall market outlook of Indonesian equities slightly weakened during the month. In the portfolio, we have slightly reduced equity exposure from around 73% at the end of August to around 71% by the end of September. The equity component underperformed the benchmark in the month of September. The underweight positions in the material sectors impacted performance negatively. Positive stock selections in the consumer discretionary sector have, however, offset the underperformance partially.
